

Donor funds a trust which pays out to either a fixed annuity or an amount to be determined by a percentage of annual value to a charity. At the donor's death, the trust dissolves and the remainder is paid out to non-charity beneficiaries, usually family members. There are various ways to set up the trust to maximize the income tax or estate tax benefits.
